g)	not to assert or rely on any such estate, interest or rights in a manner which may obstruct, delay or hinder the orderly realisation of the Society's security over the Property.
h)	the Society may enforce the mortgage by seeking a court order for possession of the Property, by selling the Property and/or by appointing a receiver to manage the Property.
i)	if the Society or any receiver obtains a court order for possession of the property, you will leave the Property.
j)	the Society may at any time transfer, charge or otherwise dispose of the mortgage.

- 4. Received my confirmation that I wish to sign the /Deed of Consent: and
- 5. Confirmed they were satisfied I understood the nature and extent of the obligations under the Deed of Consent and the impact and risks of signing it.
- 6. Provided me with a copy of Loughborough Building Society's Privacy Notice (https://www.theloughborough.co.uk/privacy-and-cookies) which I have read.
